
Here's what Elizabeth has to say about her experience:

Teen court began for me as a way of exploring my passion in law, and testing the waters to see if being a lawyer might be for me in the future. However, why I started and why I continue are vastly different. I will never forget my first case, which introduced to me the reality that I am not so different from my clients who sit across the table from me. In each client I talk with, I see bits of myself. It is not unusual for my client meetings to end in many tears and hugs.

Elizabeth's advice for new volunteers:

Often, other youth attorneys will ask how to build such rapport with clients in such short amounts of time. My honest advice is to genuinely care. Teen Court has not only solidified my goal of becoming a lawyer, it's taught me what kind I want to be: compassionate. And for that, I am forever grateful.

Lew's Corner

If you've volunteered with us before, you've likely met one of our judges, Lewis Cohn.

As a retired attorney, Lew serves as a judge at almost every Teen Court night. In "Lew's Corner," he will share some insight, wisdom, and helpful pointers!

Break your Direct Examination into "Digestible Bits."

The most common shortcoming in most direct examination of a client is an overarching question, such as: "Tell us everything that happened." Most clients are reluctant witnesses. Studies of jury conduct find that most jurors can only absorb information provided in small, "digestible" bits—an open-ended question seeking "everything" from a witness risks providing a story that is incomplete and disjointed, and which, simultaneously, loses the jury's attention and interest.



It is easier if you present your witness with smaller questions, eliciting critical facts while permitting the jury to easily grasp the information provided. **Consider the following direct examination in a shoplifting case:**

Defense Attorney Questions	Client Answers
Where were you on October 23rd, 2024?	Green's Department Store
Who were you with?	My friends, Chris and Michael
Why did the three of you go there?	Just to hang out
What items did you take without paying for them?	Some candy and other small items
What intent did you have to steal any items when you entered the store?	None
Then, why did you take these items?	My friends dared me to take them
If you were faced with the same circumstances today, what would you do?	Pay for the items

You have now established your case without "memory gymnastics" by your witness; and in a fashion that can be easily understood by the jury!
